- 5. A complete set of Bidding Documents may be acquired by interested Bidders from date of posting to April 16, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The *National Printing Office* will hold a Pre-Bid Conference on *April 2, 2018 @ 2:00* p.m. at the NPO Conference Room, 3<sup>rd</sup> Floor which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *April* 16, 2018, 2:00 p.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
  - Bid opening shall be on *April 16, 2018 immediately upon submission of bids.* at *the NPO Conference Room.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *National Printing Office* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
