WHEREAS, the Bids and Awards Committee (BAC) scheduled the Public Bidding on December 6, 2018 at 9:30 a.m. for the Provision of Freight Services to NPO for CY 2019 under Purchase Request No. 18-10-0716 dated October 23, 2018. The Approved Budget for the Contract (ABC) is ₱3,000,000.00;

WHEREAS, the BAC has commenced schedule of the procurement process for the above-stated contract/project as follows:

Pre-procurement	-	November 5, 2018 @ 9:30 a.m.
Posting to PhilGeps	-	November 13, 2018
Pre-Bid Conference	-	November 23, 2018 @ 9:30 a.m.
Opening	-	December 6, 2018 @ 9:30 a.m.

WHEREAS, on the scheduled Pre Bid conference, five (5) prospective bidders attended namely, Front Cargo Forwarders, Inc., Intertraffic Transport Corporation, Premier Logistics Inc., Transmodal International Inc. and One Stop Logistics Solutions Inc. During the conduct of pre bid, a bidder *recommended or inquired* if it was possible to get a list of the specific areas or destination of deliveries to be made with the estimated kilogram as reference in their preparation of bids/proposals;

WHEREAS, the BAC together with the End-user after a brief discussion granted the request and announced that a bid bulletin will be issued and posted relative to the inclusion in the bid form a list of areas or destination where deliveries are to be made with the corresponding estimated kilograms;

WHEREAS, on December 4, 2018 at 3:30 p.m., the BAC convened for an emergency meeting with the end-user whereby it was declared/disclosed that due to a number of factors beyond the end-user's control such as the corruption of data, bugging down of computer desktop and time constraint, they are unable to provide the list being requested. Hence, after careful consideration and thorough deliberation, the body agreed to retract and withdraw their initial decision granting said request and to immediately issue a notice of postponement of the Opening of Bids scheduled on December 6, 2018 at 9:30 a.m. and announce thereto the new schedule (copy attached);

WHEREAS, a bid bulletin will be issued in the form of a BAC Resolution stating the BAC and End-user's decision to maintain the current data of the Bidding Documents particularly the bid form;


