**WHEREAS**, the Bids and Awards Committee (BAC) scheduled the Small Value Procurement on October 21, 2019 for the purchase of 32 pcs. Adhesive Rubber Blanket under Purchase Request No. 19-10-0654 dated October 09, 2019 pursuant to R.A. 9184, Sec. 53.9 with ABC of Php55,616.00;

**WHEREAS**, the invitation for submission of price quotations for the above mentioned item/s was posted at the PhilGEPS on October 16, 2019, NPO Website & Bulletin Board located in conspicuous places of NPO premises to assure full participation from the interested suppliers;

**WHEREAS**, on the scheduled Small Value Procurement no bid was received, thus, declared failure as per NPO-BAC Resolution No. 2019-202 (copy attached);

**WHEREAS**, the BAC Chairman instructed the TWG to conduct further study on the specifications of the above stated item and come up with Resolution No. 2019-002 (copy attached) stating that the above mentioned item is no longer available in the market in piece instead it is now available in rolls but the price is higher;

**WHEREAS**, the BAC Chairman consulted the Property Section on the result of TWG's Resolution wherein the Property Section Head made a market study in coordination with the End-User, that the said item is still available in the market and that the price per piece is within the threshold of the Approved Budget of the Contract (ABC) (attached copy of Routing Slip of the Property Section Head), thus, another Small Value Procurement was scheduled on December 10, 2019;

**WHEREAS**, Request for Quotation were acquired by Bengard Industrial Corp., JSA Printing Supply and Goldenways Chemicals (copy attached);

**WHEREAS**, on the scheduled December 10, 2019 Small Value Procurement, only one (1) supplier submitted its bid:

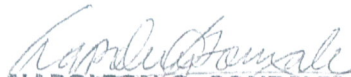
