This refers to the public bidding for the **Design & Build Infrastructure Project for Production, Planning and Control Division (PPCD), Official Gazette (OG) and Cashier Section** held on September 13, 2019, 9:30 a.m. at the NPO Conference Room.

Failure to provide the said Performance Security within the abovementioned period shall constitute sufficient ground for cancellation of the award and forfeiture of bid security.
