The Bids and Awards Committee [BAC] in its Resolution No. 2019-238 dated December 18,, 2019 has recommended the **award of 1 lot Repair & Maintenance of OCE Colorstream 3000 & Hunkeler Sheeter 3 (complete details at the back)** in favor of your firm in the amount of **Twenty Four Million Eight Hundred Thousand Pesos Only [Php24,800,000.00]** as the Single Calculated and Responsive Bid which was subsequently approved by the approving authority.

Failure to provide the said Performance Security within the abovementioned period shall constitute sufficient ground for cancellation of the award and forfeiture of bid security.

WHEREAS, the Bids and Awards Committee (BAC) scheduled the Public Bidding on December 3, 2019 at 1:30 p.m. for the Procurement of 1 Lot Repair & Maintenance of OCE Colorstream 3000 & Hunkeler Sheeter 3 under Purchase Request (PR) No. 19-10-0658 dated October 14, 2019 with an Approved Budget for the Contract (ABC) of ₱24,800,000.00;

WHEREAS, the date of bidding and the item/s to be procured have been previously posted on PhilGEPS and NPO Bulletin Board on November 12, 2019 located in a conspicuous place of National Printing Office (NPO) to assure full participation from the bidders and to invite as many interested bidders as possible;

WHEREAS, the representative/s of NPO-COA, NAPOWA, NPO-MPC, the Philippine Chamber of Commerce and Industry and the Philippine Business for Progress were informed/invited in writing to be a witness (Observer) for the said undertaking pursuant to Section 13.3 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the BAC convened a pre-bid conference on November 21, 2019 at 1:30 p.m., wherein two (2) prospective bidders attended the said conference, namely Ferros Systemas Corporation and Holy Family Printing Corporation;

WHEREAS, a Supplemental Bid Bulletin dated November 26, 2019 was issued and posted on PhilGEPS relative to the modification &/or amendment made therein to the Bidding Documents **[copy attached]**;

WHEREAS, the date of the initial schedule for the Opening of Bids was later moved to December 5, 2019 at 1:30 p.m. in view of Malacañang's declaration to suspend government offices in Metro Manila on December 3, 2019 effective 12:00 noon due to the continuing inclement weather brought about by Typhoon Tisoy as per Memorandum Circular No. 73, series of 2019 duly signed by Salvador C. Medialdea, Executive Secretary, Office of the President. Hence, a Notice of Postponement was immediately issued and posted on PhilGEPS on December 3, 2019 prior to 12:00 noon **[copy attached]**. Likewise, a letter to the different Observers have also been sent informing them of the postponement and of the new schedule of the Opening of Bids for the above-mentioned project/item;

WHEREAS, on the revised schedule, only one (1) bidder submitted their bid/proposal for the said item, namely: Holy Family Printing Corporation. The result was:




