**SUPPLEMENTAL BID BULLETIN
PUBLIC BIDDING**

**NOTICE OF NEW SCHEDULE
FOR THE SUBMISSION AND OPENING OF BIDS**

The National Printing Office [NPO], through its Bids and Awards Committee [BAC] announces the **new schedule of the Submission and Opening of Bids** for the following projects which were originally scheduled on March 30, 2020 and were subsequently postponed indefinitely in view of the stringent safety measures and essential guidelines adopted and/or imposed by the Executive Branch of government for the effective management of the situation of the novel coronavirus (covid-19) affecting most parts of the world:

- **June 3, 2020 at 9:30 a.m.** - Supply, Delivery, Installation, Testing & Commissioning of Electrical Circuit Breaker (ECB)
- **June 3, 2020 at 1:30 p.m.** - Complete Set of Computers & Adobe Creative Cloud

Moreover, pursuant to GPPB Resolution No. 09-2020 specifically under item no. 6 which provides and/or grants for the acceptance/assent/receipt of the following **alternate documentary requirements for procurement activities** in consideration of the current circumstances brought about by the covid-19 pandemic. Whereby access to financial institutions, regulatory and other offices are limited and restrictions on transport and travel are being implemented:

1. Unnotarized Bid Securing Declaration;
2. Expired Business or Mayor's permit with Official Receipt of renewal application, subject to submission of Business or Mayor's permit after award of contract but before payment;

3. Unnotarized Omnibus Sworn Statement subject to compliance therewith after award of contract but before payment; and
4. Performance Securing Declaration (PSD) in lieu of a performance security to guarantee the winning bidder's faithful performance of obligations under the contract, subject to the following:
 - a. Similar to the PSD used in Framework Agreement, such declaration shall state, among others, that the winning bidder shall be blacklisted from being qualified to participate in any government procurement activity for one (1) year, in case of first offense or two (2) years, if with prior similar offense, in the event it violates any of the conditions stated in the contract. A copy of the PSD form is attached hereto as Annex "A";
 - b. An unnotarized PSD may be accepted, subject to submission of a notarized PSD before payment, unless the same is replaced with a performance security in the prescribed form; and
 - c. The end-user may require the winning bidder to replace the submitted PSD with a performance security in any of the prescribed forms under Section 39.2 of the 2016 revised IRR of RA No. 9184 upon lifting of the State of calamity, or community quarantine or similar restrictions, as the case may be.

Additionally, the BAC shall determine or validate the existence of the aforementioned conditions and/or circumstances and may require the submission of documentary proof for this purpose.
