- 3. PhP512,400.00 or 30% of the total contract price For Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.

The failure of your company to submit the above requirement within ten (10) calendar days from receipt of this Notice shall constitute a sufficient ground for the cancellation of this award and forfeiture of the bid security.
