This is with reference to the public bidding conducted by the National Printing Office – Bids and Awards Committee (NPO-BAC) on 23 July 2024 at 1:30 p.m. for the procurement project **“Supply and Delivery of 60 Rolls Tarpaulin”** with Project Identification No. NPO-BAC-009-24.

3. **PhP309,600.00 or 30% of the total contract price** – For Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.
