"For ongoing contracts and SLCC, should there be an attachment or just the statement (table/matrix)?"	For ongoing contracts, only the form Statement of All On-Going Government and Private Contracts Including Contracts Awarded but not yet Started is required during bid submission. However, the attachments will be validated during the post-qualification stage.  For the SLCC, attachments such as the End-User's Acceptance with a rating of at least "Satisfactory," or the Official Receipt(s) or Sales Invoice issued for the

	contract, are required. These will also be validated during post-qualification.
"During the opening of the bids, do you require us to submit a Certificate of Clearances from SSS, PhilHealth, and Pag-IBIG?"	No. Updated Certificates of Clearances from SSS, PhilHealth, and Pag-IBIG will be submitted during the post-qualification stage.
"Do you allow zero costing for supplies and equipment?"	Yes, zero costing for supplies and equipment is allowed.
"Kindly confirm if the qty indicated on the supplies and equipment on page 45 of Bidding Docs refers to the total quantity for the year or is it based on the delivery per frequency indicated?"	The quantity indicated on the supplies and equipment on page 45 of the Bidding Documents refers to the total quantity for the year.
"If not total, for those without frequency indicated, is it annual or monthly delivery?"	For items without a frequency indicated, the total quantity is for one year. The supplies must be delivered in the same quantity on a monthly basis and will be stored by the Building Administrator for monitoring and control purposes.

- III. This shall be an integral part of the Bidding Documents and the same shall be enclosed in the technical bid envelope/ components and shall be signed by the bidder accordingly.
- IV. Bidders not complying with the above instructions shall be declared ineligible.
