6. Proposal must be duly received by the National Printing Office through the Disposal Committee Secretariat at the address below until **1:30 PM of November 21, 2024**. All bids must be accompanied by a bid security/bond in any acceptable forms and in the amount stated in Bidding Documents.

Opening of the proposal shall be on **November 22, 2024, 9:30 AM** at **John Sylvannus Leech Training Room, 3F National Printing Office, Edsa corner, NIA North Road, Diliman, Quezon City, Philippines**. Bids shall be opened in the presence of the Bidder or its authorized representatives. Late bids shall not be accepted.
